Pension Application of Abraham Randolph, W11108, transcribed by Roy Randolph

State of Alabama, Lawrence County

On this 20th day of August in the year 1832 personally appeared in open court before James B. Wallace Judge of the county court of said county of Lawrence at a stated session of said court now sitting at the Court house in said county Abraham Randolph aged seventy years as well as I recollect who first being duly sworn according to Law doth on his oath make the following declaration in order to obtain the benefit of the act of Congress passed June 7th 1832 that he entered the service of the United States under the following named officers and served as herein stated he states that he was drafted in the army of the United States in Seventeen hundred and Eighty in Caswell County North Carolina under General Butler, Colonel William Moore, Elija [sic] Moore, Maj. James Wilson, Captain Walter Tate, Lieutenant John ___ Esquire at Caswell Courthouse Marched to Hillsborough from thence to Salisbury thence to Charlot [or Sharlot, i.e., Charlotte, North Carolina] thence to Bells Mill. Joined General [William Lee] Davidson at Six Mile Creek, New Providence at which place he remained until discharged which discharge has been lost this service was for three months performed second service in Seventeen hundred and Eighty one at this time he volunteered under Col. ___ [new page and name seems to be left off] and General Butler he marched in the month of September Seventeen Eighty One against the British and Tories near Wilmington where he was in an engagement at the Raft Swamp where he lost his horse and equipage Except his gun this Term of service was also three months after this battle he was appointed one of those who had it in charge to carry Home the horses he supposed unable to perform a campaign on foot. he lived in North Carolina twelve or thirteen years in South Carolina Twenty five or six years in Alabama twelve or thirteen years.

Lydia Randolph Pension Application

State of Alabama Walker County

On this Third day of April 1847 personally appeared before the Subscriber judge of the County Court for said County, Lydia Randolph [maiden name, Lydia Dill], a resident in said county of Walker, aged about Eighty years; who being first duly sworn according to law, doth, on her oath, make the following declaration in order to obtain the

benefit of the provision made by the act of Congress passed July 7 1838 entitled “An act granting half pay and pension to certain widows”—that she is the widow of Abraham Randolph who was a volunteer soldier in the Army of the Revolution; and that her said husband was a citizen of Rutherford County in the State of North Carolina at the time he entered the Service of the United States; and that he fought for the Independence of his Country at the Battle of the Raft-Swamp; and she further declares, that, her said husband, the said Abraham Randolph was a pensioner of the United States in the State of Alabama aforesaid up to the time of his death, but that his pension Certificate has since been destroyed by fire and cannot now be produced. She further declares that she was married to the said Abraham Randolph in the year Seventeen-hundred and ninety two, but being illiterate and having no family record of the fact, she cannot specify the day of the month in that year on which said marriage was celebrated; nor has she, nor can she obtain any record or documentary evidence of her marriage with the said Abraham Randolph, tho’ she has through herself & friends made diligent inquiry for such evidence where it could likely be had and so far as she can learn or believe, none such exists. That her husband, the aforesaid Abraham Randolph died on the 29th day of April 1837; that she was not married to him prior to his leaving the Service but the marriage took place previous to the first of January Seventeen hundred and ninety four, viz.; at the time above stated. Declaration of William and Nancy Dill

Gabbert Judge of the Court of Probate for said county William Dill and Nancy Dill his wife who after being duly sworn deposed and saith that they are certain that Abraham and Lidia Randolph was married prior to the year 1794 from these circumstances, that they William and Nancy Dill was themselves married the year 1800 and that Abraham and Lidia Randolph had four children born at the time they William and Nancy Dill was married and that Abraham and Lidia Randolph was married between one and two years before any child was born and that there was about two years between their children and they further state that Abraham and Lidia Randolph was married in Greenville District South Carolina and William Dill further states that he was at the wedding and well recollects the assembling of the people assembling for the wedding and from the above circumstances is sure it was prior to 1794.

Jasper Ala. 18th June 1853

Dear Sir:

Some twelve months ago I made application through a Mr. Stevenson this Company for a pension which I thought was due to my Mother (Lydia Randolph widow of Abraham Randolph). The papers set out to show the facts of the case & they have been long since in your office or should have been. My Mother being dead the claim is set up in favor of her children whose names and ages are all set forth in the proof. – I have not recently heard anything from the claim. – I gave a power of attorney & made a Mr. Combs (first name not remembered) my attorney & it may be he has presented the papers. – I wish to know whether anything has been done in the case & if so what? My agents don't write me & I am very desirous to hear from it – and if the claim has been allowed please send it to me at Jasper by mail in a check or warrant – and if it has not been allowed notify me of the defects if any are in the papers. – Yours & C Jno D. Claim for Military Service

I certify that, in conforming with the law of the United States of the 7th July 1838, Lydia Randolph, deceased, widow of Abraham Randolph, who was a private in the Revolution, was entitled to a pension, and having died on the 4th October 1847 her only surviving children, John D. Randolph, James Randolph, Abraham Randolph, Robert Randolph and Christiana Givens are entitled to the amount at the rate of twenty dollars per annum, from 29th April 1837 when he died to 4th March 1841.

Also acts 3rd March 1843 & 17th June 1844, at the same rate, from 4th March 1843 to 4th October 1847, when she died. Payable to John D. Randolph, Administrator.
